FOR THE PURPOSE OF AUTHORIZING APPLICATION FOR A MARYLAND COMMUNITY DEVELOPMENT BLOCK GRANT ON BEHALF OF PATUXENT HABITAT FOR HUMANITY, INC.

WHEREAS, the State of Maryland through the Department of Housing and Community Development has solicited applications from eligible jurisdictions to apply for funding under the Maryland Community Development Block Grant ("CDBG") Program; and

WHEREAS, Calvert County is eligible to apply for funds from the Maryland CDBG Program through the Maryland Department of Housing and Community Development; and

WHEREAS, Patuxent Habitat for Humanity, Inc., has requested that the Board of County Commissioners of Calvert County, Maryland (the "Board of County Commissioners") submit an application on their behalf for the construction a single-family home at 91 Mason Road, Prince Frederick; and

WHEREAS, the Board of County Commissioners deems it to be in the best interest of Calvert County to submit an application, on behalf of Patuxent Habitat for Humanity, Inc., to the Department of Housing and Community Development for funding under the CDBG program for the construction of a single-family home at 91 Mason Road, Prince Frederick; and

WHEREAS, the Board of County Commissioners, after due notice was given, held a public hearing on May 15, 2012 to review Calvert County's Community Development Block Grant Application; and

WHEREAS, in public session on May 15, 2012, the Board of County Commissioners approved Calvert County's Community Development Block Grant Application, on behalf of Patuxent Habitat for Humanity, Inc., to the Department of Housing and Community Development for funding under the CDBG program for the construction a single-family home at 91 Mason Road, Prince Frederick.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Calvert County, Maryland, that the County shall submit an application for Community Development Block Grant funds in the amount of One Hundred Thirty-Two Thousand Dollars (\$132,000.00) on behalf of Patuxent Habitat for Humanity, Inc. for the construction of a single-family home at 91 Mason Road, Prince Frederick.

BE IT FURTHER RESOLVED, that the President of the Board of County Commissioners of Calvert County, Maryland is authorized and empowered to execute any and all documents required for the submission of the application.
