

SUBJECT: Extending the Term of the
Cliff Stabilization Advisory Committee

**PERTAINING TO THE EXTENSION OF THE TERM OF
THE CLIFF STABILIZATION ADVISORY COMMITTEE**

WHEREAS, the Board of County Commissioners for Calvert County, Maryland established the Cliff Stabilization Advisory Committee (“Advisory Committee”) on November 23, 2010 by Resolution #46-10;

WHEREAS, by Resolution #46-10, the Advisory Committee is cease to exist on December 31, 2012 unless action is taken by the County Commissioners to extend its existence;

WHEREAS, the Chairman of the Advisory Committee requested and the Board of County Commissioners for Calvert County, Maryland agree that an extension of the term of the Advisory Committee is in the best interest of the health safety and welfare of the residents of Calvert County, Maryland.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Calvert County, Maryland that the Cliff Stabilization Advisory Committee shall remain in existence until June 30, 2013, at which time it shall cease to exist unless further action is taken by the Board of County Commissioners for Calvert County, Maryland.

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of this Resolution shall be enforceable and valid; and

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein; and

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation.
