**TO APPLY FOR FUNDING UNDER THE MARYLAND COMMUNITY DEVELOPMENT
BLOCK GRANT PROGRAM FOR FUNDS AWARDED
THROUGH THE FEDERAL CARES ACT**

WHEREAS, the State of Maryland through the Department of Housing and Community Development has solicited applications from eligible jurisdictions to apply for funding under the Maryland Community Development Block Grant Program for funds awarded through the federal CARES Act;

WHEREAS, Calvert County, Maryland is eligible to apply for funds from the Maryland Community Development Block Grant program through the Maryland Department of Housing and Community Development;

WHEREAS, the County Commissioners of Calvert County, Maryland (the "County Commissioners") is a unit of general local government receiving or expecting to receive CDBG funds;

WHEREAS, after due notice, the County Commissioners have held the required public hearings on June 9, 2020 in order to hear public comments related to the formulation of Calvert County, Maryland's Block Grant Application; and

WHEREAS, the County Commissioners understand and acknowledge that they would be responsible for completion of grant activities and any corrective actions including the repayment of funds if necessary.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Calvert County authorize the submittal of an application for the Community Development Block Grant funds in the amount of Three Hundred Eleven Thousand One Hundred Dollars (\$311,100.00) this 9th day of June, 2020, for the following non-profit and community-based organization project(s) that prevent, prepare for, and respond to the coronavirus crisis:

- Senior Services
- Homeless Assistance
- Rental Assistance for Low- and Moderate- Income Households

BE IT FURTHER RESOLVED that the President of the Board of County Commissioners, Kelly D. McConkey, is authorized and empowered to execute any and all documents required for the submission of an application.

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid.

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation without publication of a fair summary.






