Important Information Regarding Interim, Temporary, and Final Protective Orders

- ❖ Keep a copy with you at all times
- ❖ Keep a copy in any and all vehicles in which you are travelling
- ❖ Keep a copy at any alternate addresses in which you might reside
- ❖ Provide a copy to any daycare, school, church, etc.
- ❖ Provide a copy to your employer
- ❖ Provide copies to relatives and close friends

A copy of your Protective Order is always available in the county in which it was issued.

If an order is amended/modified, dismissed, denied, or rescinded, make sure all of those who received a copy are notified immediately
