BOCC meeting next week

The next BOCC meeting is scheduled for Tuesday, July 14 at 10 a.m. Due to COVID-19, county buildings are closed to the public. Citizens are invited to tune in online to watch the meeting live to learn more about the local community. Public Hearings will also be held virtually. Like the BOCC meetings, the public is encouraged to attend by viewing the live stream on the county’s website, or calling the

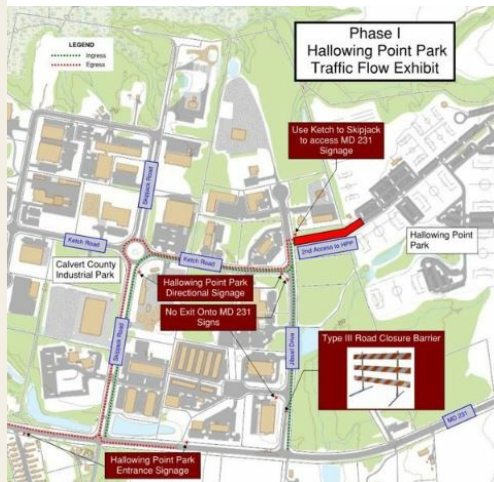
phone numbers above and entering the meeting code above to listen to the meeting. If you wish to comment on a public hearing matter, dial *9 from your phone after the meeting begins.

Comments will be limited to two minutes for an individual and five minutes for the designated representative of a group. The comments regarding a public hearing matter may also be mailed to the attention of the Clerk to the Board at 175 Main St., Prince Frederick, MD 20678. Those received by close of business the day prior to the close of the official record will be considered.

It's hurricane season - what you need to know

Throughout hurricane season, Calvert County is at risk for strong winds, heavy rain, inland flooding and other severe weather. The BOCC and the Department of Public Safety take your safety seriously and urge residents to prepare for emergency situations using preparedness tools such as the recently-updated "Calvert Prepare" mobile app, the County's emergency notification system Calvert County Alert and Smart911 to set up a safety profile for 911 calls.

Be aware and prepare this season to keep you and your loved ones safe.



Reminder: Hallowing Point Park's (HPP) second entrance is now open

The entrance extends from the back of HPP to Jibsail Drive and provides secondary access for those entering and exiting the park.

Drivers may only make right turns into and out of the main park entrance onto MD 231 and are advised to follow directional signs posted in the area for entering and exiting the park, as traffic patterns will be adjusted.

Residential inspections have resumed

The Department of Planning & Zoning, Inspections and Permits Division, has resumed inspections of occupied residential dwellings. Residents will be required to complete a brief COVID-19 checklist prior to inspection. During inspection, occupants and inspectors must wear a face covering and maintain a minimum six-foot distance.
