Vegetative Removal Permit Application Guidelines

- This permit application and all required information must be submitted to the Inspections & Permits Division for review by all applicable County agencies; incomplete packages and/or unsigned applications will result in processing delays.
- All applications **must include a property sketch**, to scale, showing the location and limits of disturbance for the proposed vegetation or individual tree removal. Distance between the location of the activity and buildings, roads, steep slopes ($\geq 25\%$), open water, wetlands and direction of overland water flow should be shown. Applications submitted without a sketch may be rejected.
- Photos may eliminate the need for a site visit and expedite permit approval.
- Individual trees proposed for removal must be marked with flagging or paint for inspection purposes.
- Trees and vegetation removed must be replaced with native plants. A refundable planting bond may be required to assure adequate survival of the planting.
- Access to the water/pier must be non-structural and must be flagged in the field.
- Pruning of trees may only be performed by the homeowner or a State of Maryland **Licensed Tree Expert**. Topping of trees is **not permitted**, only pruning using proper horticultural practices.
- The project is not exempt from other federal, state or local permits that may be required for the proposed activity. Any required State and federal permits must be obtained prior to permit approval.
- Proposed activities within a wetland, at or below mean high water, or within wetlands or waterways require review/approval by the Department of Natural Resources, Army Corps of Engineers, Maryland Department of the Environment, and Calvert County. A copy of all State and Federal permits or Letter(s) of Exemption must accompany this permit application. See information sheets pertaining to your project for other special instructions.
- The permit must be posted conspicuously at the front of the lot.
- Permits expire 1 year after issuance.
- Inspections are required as a part of this permit. To schedule an inspection call the Department of Community Planning & Building at 410-535-2348.
